#### Section 504 Grants:

- Must be 62 years of age or older at application
- \$10,000 maximum lifetime grant assistance
- Owner-occupied single-family home in an eligible rural area
- Repairs to address health/safety hazards and/or make home accessible

#### Section 504 Loans:

- Fixed 1% interest rate
- 20-year term
- Outstanding 504 loan balance not to exceed \$40,000
- Owner-occupied property in eligible rural area
- Repairs to improve or modernize home

# SECTION 504 HOME REPAIR LOAN / GRANT PROGRAM

### **Program Objective:**

Assist very low-income owner-occupants of modest single-family dwellings in rural areas repair their homes.

#### **Loan Purposes:**

Loan funds may be used to remove health and safety hazards, improve or modernize a home, or make the dwelling accessible for household members with a disability.

#### **Grant Purposes:**

Grant funds may be used *only* for repairs and improvements that will remove health and safety hazards or to make dwellings accessible for household members with disabilities.

#### **Terms & General Eligibility Requirements**

#### 504 Loan

- Fixed interest rate of 1% and term of 20 years.
- The adjusted household income may not exceed the very low income limit for area: https://eligibility.sc.egov.usda.gov/eligibility/welcomeAction.do?pageAction=sfpd
- Applicant must demonstrate loan repayment ability total debt ratios not to exceed 41% of qualifying repayment income.
- Lack asset resources to meet repair needs; non-retirement assets in excess of \$15K (or \$20K for elderly or disabled household) must be used to reduce the loan request.
- Acceptable credit history reasonable ability and willingness to meet debt obligations.
- Loans of \$7,500 or more will be secured by a mortgage; < \$7,500 are note only.
- Applicant must own (life estate/use acceptable) and occupy the property.

#### 504 Grant

- At least one applicant must be 62 years of age or older at the time of application.
- Lifetime grant assistance to any one household or one dwelling cannot exceed cumulative total of \$10,000.
- The adjusted household income cannot exceed the very low income limit for area:

- Applicants must own (life estate/use acceptable) and occupy the property.
- Lack asset resources to meet repair needs; non-retirement assets in excess of \$15K (or \$20K for an elderly or disabled household) must be used to reduce the grant request.

• Grants must be repaid if the home is sold or otherwise transferred within three years of signing Grant Agreement.

#### **Dwelling Requirements**

- Must be a single-family dwelling located in an eligible rural area. https://eligibility.sc.egov.usda.gov/eligibility/welcomeAction.do
- The property must be considered modest, not used for rental or income-producing purposes or have a value in excess of the applicable area loan limit.
- Manufactured homes must be on a permanent foundation and applicant must also own the site/land where the unit is located.
