"Town of Byron Zoning Law - Battery Energy Storage System" TO THE GENESEE COUNTY PLANNING BOARD PURSUANT TO GML 239-M

WHEREAS, the Town Board of the Town of Byron has introduced a proposed local law entitled **"Town of Byron Zoning Law - Battery Energy Storage System"** to amend the current zoning ordinance, and

WHEREAS, on November 13, 2024 the Town Board of the Town of Byron declared itself lead agency for purposes of SEQRA review of the proposed action and completed Part 1 of the Full Environmental Assessment Form, and

WHEREAS, the Town Board of the Town of Byron is required to refer any adoption or amendment of a zoning ordinance or local law to the County Planning Board pursuant to GML 239-m.

NOW, THEREFORE, Town Board of the Town of Byron hereby refers the proposed local law entitled **"Town of Byron Zoning Law - Battery Energy Storage System"** to the Genesee County Planning Board for a report and recommendation thereon, a copy of which is attached hereto and made a part thereof, and the Town Clerk is hereby directed to enter said proposed local law into the minutes of this meeting.

AND IT IS FURTHER RESOLVED, that the Town Clerk is directed to transmit a copy of this resolution and the completed portions of the Full Environmental Assessment Form Part 1 to the Genesee County Planning Board.

AND IT IS FURTHER RESOLVED, that failure of the Genesee County Planning Board to provide said report and recommendation to the Town Board within thirty (30) days after receipt of the referral by the Town shall be deemed approval of the proposed local law.

-Karen Jaysenski wants to know what the law would be

-Supervisor Hensel states the law covers residential and commercial guidelines

-Jim Lamkin wants to know if something could be put into the law regarding training specifically for the fire departments how to deal with the lithium batteries if there were a fire.

-Reggie McDonald states that a call will be made to the solar company and they will tell the company how to proceed. The gates would be locked so the fire department would not be able to enter. The fire department would need to just keep it from spreading

-Jim Lamkin is requesting that a mandatory training be put in some kind of contract that fire departments is required to have training on battery fire protection.

-Councilman Knickerbocker states that it is his opinion that a request like that not go into a zoning law rather it should be in a fire contract if it needs to be documented. He states he trusts the departments are doing what they need to have the knowledge of how to fight a fire involving the solar batteries.

-Steve Lockner states that when the pumping station was put in the fire department worked with the pumping station employees and did mock training to learn what to do. So the fire departments do train for what comes up in the area.

-Bridgette Cook states that in the application paperwork it states that there needs to be an emergency response plan in place and a fire safety compliance plan.

ADDENDUM TO MOTION OF NO CONFIDENCE

-Per the request of Councilman Knickerbocker he is requesting an addendum to the initial Motion of No Confidence be made for the following reason(s):

On November 27th, 2024 the following items were brought to my attention which I find to be a continuation of the behavior the previous items discussed are as follows; 1. On November 25th Supervisor Hensel organized a meeting with the Byron fire departments. At no point to date did she attempt to inform me (Councilman Nathan Knickerbocker), a liaison with the Byron Fire Department, to attend, or even know of, this meeting or any of the information discussed within. Additionally, Supervisor Hensel only contacted liaison Martin Dilcher on Saturday, November 23, 2024. It is a well-established and known fact that I and Mr. Dilcher are the liaisons for the fire departments and are meant to represent the interests of the board via our positions as liaisons and that Supervisor Hensel has both of our contact information. Her failure to, at a minimum, inform me of this meeting is a continuation of her refusal to act in a professional manner accompanied by proper communication. 2. Supervisor Hensel has seemingly taken out an article with the Batavia Daily News to promote her meetings being held at the Town Hall on the fourth Wednesday of every month. This forum is being done solely by the Supervisor. I find this behavior unacceptable as the town already has held a public forum and numerous public meetings regarding all of the issues presented in her article published on November 26th, 2024 (attached hereto). Supervisor Hensel continues to misrepresent information through her actions and is seemingly attempting to promote herself above that of the Board and the town's employees as a whole.

-Councilman Knickerbocker asked the Supervisor why he was not contacted by her to tell him there was a meeting? Why was only one liaison contacted?

-Supervisor Hensel stated only two board members can attend.

-Councilman Knickerbocker asked who called the meeting.

-Reggie Macdonald stated "the town" called the meeting.

-Councilman Knickerbocker asked if the Deputy Supervisor Josh Kent was there.

-Councilman Dilcher stated yes he was

-Councilman Knickerbocker asks Supervisor Hensel again why was Josh Kent called but I the liaison was not called to the meeting.

-Supervisor Hensel states again there are only two board members allowed to attend

-Councilman Knickerbocker asks Supervisor Hensel if she took the article out in the Batavia Daily News or was she approached.

-Supervisor Hensel states she picked up the phone in her office and she did not take the article out.

Fireman's Contract Discussion

-Councilman Klycek states the fire protection contract that he just reviewed states that by March 1, 2025 the fire departments should have a plan of merge. He states South Byron does not even have an attorney to draw up a plan of merger. It also states the fire departments need to file a petition to the county no later than October 1, 2025. This just isn't possible. He recommends the town use the 2024 contract, plug in the new numbers and move on. -Lengthy discussion had regarding how to move forward.

-Reggie Macdonald states when he showed up to the meeting he asked Supervisor Hensel is this meeting about the contracts. She stated no, it's about the merger.

-Councilman Knickerbocker states he feels a merge is needed but needs to be done the right way. -Councilman Dilcher states the town needs to move forward and the goal needs to be to have a merge of company's into one. He feels that the contract should state something to the effect that by the beginning of January 2026 a plan will be in place to start moving forward to merge.

-Councilman Thompson asks what is considered a plan. Is it a location?

-Peter Lockner states what is the benefit of having two separate corporations for the town? The question is does the town want to continue to support to separate corporations or does the town want to work towards the most efficient for fire protection.

-Supervisor Hensel states the contract that she asked the attorney to draft was what she felt that the town board wanted to work towards.

-Councilman Klycek states it is his impression that this conversation states to change the dollar amounts to reflect the 2025 budget and add an agreed upon verbiage regarding merging into the contract

-Councilman Thompson states he feels a detailed plan does need to be in the contract to continue to move forward or we are going to be in the same spot next year

-Supervisor Hensel states she feels the contract needs to have dates in it to try and keep things moving forward. To have next year come and just start discussing the plan is too far out. The increase cost in the budget was significant amount of money. Amending last year's contract is throwing money at the problem not the solution.

-Steve Lockner states that if it's a money issue then just pay one company and be done. -Reggie Macdonald asks during negotiations regarding the merge that discussions should be made public. So everyone in the public should be able to voice their opinions and concerns.
