WHEREAS, the Town of Byron's current Code does not adequately meet the Town's objectives, which include allowing the Town of Byron to adopt a budget for the fiscal year 2025 that requires a real property tax levy in excess of the "tax levy limit" as defined by General Municipal Law §3-c, and

WHEREAS, on October 9, 2024 the Town Board of the Town of Byron referred the Local Law to the Genesee County Planning Board pursuant to GML §239-m, and

WHEREAS, more than 30 days have elapsed and the Genesee County Planning Board failed to submit a report, and

WHEREAS, the Town Board adopted a Resolution on October 9, 2024, which classified the Local Law as an Unlisted Action under the New York State Environmental Quality Review Act ("SEQRA"), and

WHEREAS, the Town Board held a public hearing on November 7, 2024, and

WHEREAS, the Town Board has prepared a Short Environmental Assessment Form ("SEAF") which is attached hereto, and

WHEREAS, the Town Board assumed lead agency status pursuant to 6 NYCRR 617.6(b)(1);

WHEREAS, The Town Board has considered the content of the proposed, Local law, the SEAF, communications from interested agencies, and

WHEREAS, The Town Board has considered any relevant public input, and

WHEREAS, the Town Board has thoroughly analyzed the relevant concerns discussed in the attached negative declaration of environmental significance, and has determined that no significant adverse environmental impacts will result from the proposed Local Law, and

NOW, THEREFORE, the Town Board hereby finds that enactment of the proposed Local Law will not have any significant adverse impacts on the environment.

AND THEREFORE, the Town Board further resolves to adopt a negative declaration of environmental significance with respect to the adoption of the proposed Local Law.

AND THEREFORE, the Town Board hereby adopts the attached negative declaration of environmental significance and incorporates it herein.

NOW, THEREFORE, Town Board of the Town of Byron hereby refers the proposed local law entitled **"Town of Byron Zoning Law - Battery Energy Storage System"** to the Genesee County Planning Board for a report and recommendation thereon, a copy of which is attached hereto and made a part thereof, and the Town Clerk is hereby directed to enter said proposed local law into the minutes of this meeting.

AND IT IS FURTHER RESOLVED, that the Town Clerk is directed to transmit a copy of this resolution and the completed portions of the Full Environmental Assessment Form Part 1 to the Genesee County Planning Board.

AND IT IS FURTHER RESOLVED, that failure of the Genesee County Planning Board to provide said report and recommendation to the Town Board within thirty (30) days after receipt of the referral by the Town shall be deemed approval of the proposed local law.

After filing is complete, the Town will receive a post card from the Secretary of State verifying that the law was filed, which the Town Clerk is directed to file in the Town Clerk's office as proof of filing.

WHEREAS, Section 20, subsection 4 of New York State's Municipal Home Rule Law allows for the introduction of a proposed local law by a member of a Town Board, and

WHEREAS, the Town Board of the Town of Byron hereby introduces the proposed "Town of Byron Zoning Law - Battery Energy Storage Systems," a copy of which is attached hereto and made a part hereof, and the Town Clerk is hereby directed to enter said proposed local law into the minutes of this meeting.

AND THEREFORE, the Town Board of the Town of Byron finds that the adoption of the current version of the proposed local law entitled **"Town of Byron Zoning Law - Battery Energy Storage System"** would qualify as a Type I action under SEQRA because it would involve a change in allowable uses within at least one district affecting 25 or more acres of the district under 6 NYCRR 617.4(b)(2).

AND THEREFORE, the Town Board of the Town of Byron further resolves that the proposed action is classified as a Type I Action under SEQRA.

AND THEREFORE, the Town Board of the Town of Byron will review continue its SEQRA review of the proposed local law by preparing a Full Environmental Assessment Form.

AND THEREFORE, the Town Board of the Town of Byron will hold a public hearing on proposed local law entitled **"Town of Byron Zoning Law - Battery Energy Storage** System" on December 11, 2024 at 7:00 PM at the Byron Town Hall.

AND THEREFORE, the Town Board of the Town of Byron will review any relevant submissions and comments related to the proposed local law in order to make a determination of environmental significance under SEQRA.

Water Improvement Benefit Area #1 Update: Scott Mattison

-Contract A- Pilon Construction on July16 2024 had meant substantial completion with all the water turned on. In May of 2025 a final walk through of the project will be done to determine if there is anything that needs to be touched up at all.

-Contract B- Rochester Pipeline meant substantial completion June 28, 2024. Completion of restoration has not been done. Rochester Pipeline will be back out to try and complete restoration on November 18, 2024. Hydro seeding will not be done at this time; it will be done in the spring. In May of 2025 a walk-through of this project will also be done.

Sewer- Waste Water Treatment Project

-Bill Davis from MRB speaks regarding the WIIA Grant Approval. MRB applied for the grant on behalf of the Town of Byron. A letter was received from NYS EFC on November 1, 2024 that the Town of Byron has been awarded a 2024 enhanced award in the amount not to exceed \$2,706,250.00. This amount is in addition to our 2023 WIIA award. Total grant funding at this point towards the waste water treatment project is approximately \$6.4 million dollars. That will leave approximately \$5.4 million dollars that the Town would be eligible for an interest free loan.

-Supervisor Hensel signed the agreement of acceptance on November 4, 2024 and sent the confirmation back to NYS Environmental Facilities Corporation.

-WQIP grant has been applied for and are waiting on an answer

-CBDG grant may be applied for around July of 2025

-Supervisor Hensel explains that the type of EFC Grant that we have received the RFQ is necessary to be done.

-MRB Engineering Firm and Square Engineering Firm were the two companies that responded and are interested in being hired for engineering services on the waste water treatment project -Discussion held regarding how to interview the two candidates and how to move forward

-Councilman Knickerbocker states both firms seem qualified. MRB has been on the project from the beginning. MRB has helped out significantly with the grants we have received thus far. He feels that the town would be better suited with MRB due to that.

-Councilman Dilcher agrees with Councilman Knickerbocker and would also recommend continuing with hiring MRB for the project.

-Councilman Thompson states he agrees with both Councilman Dilcher and Councilman Knickerbocker. He states this one of the biggest projects we have done in the town and sees no point in not continuing with the relationship we have built with MRB.

WHEREAS, the Code Enforcement Officer conducted an exterior inspection of the Property and provided a report from said inspection to the Town Board; and

WHEREAS, the Town of Byron Code Enforcement Officer affixed a notice to the Property of the numerous violations of the Building Code and unsafe conditions at the Property; and

WHEREAS, on September 11, 2024, the Town Board found that the Property is in violation of Town of Byron Unsafe Buildings Law and the Uniform Construction Code; and

WHEREAS, the Order of Correction was served in accordance with the town code with notice of hearing regarding the same; and

WHEREAS, the Town Board held a hearing on October 9, 2024 at which the property owner did not appear; and

NOW THEREFORE, the Town Board hereby finds that the property owner has refused to comply with the Order of Correction and now directs Town of Byron Staff to remedy the unsafe and dangerous conditions at the Property.

AND THEREFORE, the Town Board orders that any expense associated with the Town of Byron's remedy of the unsafe and dangerous conditions at the Property shall be assessed against the Property as permitted by Town Unsafe Buildings Law Section 12 and Article 15 of the Town Law.

<u>NYS DOT Five Year Extension Snow & Ice Removal Contract Resolution #106</u> Councilman Dilcher offered the following resolution and moved for its adoption:

This Agreement made this 13th day of November, 2024 by and between THE PEOPLE OF STATE OF NEW YORK (hereinafter referred to as "STATE"), acting by and through the Commissioner of Transportation of the State of New York (hereinafter referred to as "COMMISSIONER"), and the Highway Superintendent of the TOWN OF BYRON (hereinafter referred to as "MUNICIPALITY") as follows: WHEREAS, the COMMISSIONER and the MUNICIPALITY have entered into an Agreement No. D014872 entitled Municipal Snow and Ice Agreement between the New York State Department of Transportation and the Municipality of TOWN OF BYRON dated 12/18/2019 ; and WHEREAS, the term of the said Agreement is for a period of five years commencing July 1, 2019 and the said Agreement provides that the parties may at the end of each 5-year term of the Agreement extend such term for an additional five years; and WHEREAS, the present term of the Agreement, as extended, expires June 30, 2024; and Section 1 of said Agreement allows up to a maximum of three extension periods of five years each for a maximum contract life of twenty years; WHEREAS, Sections 5 of the said Agreement provides that the COMMISSIONER shall furnish the MUNICIPALITY with a suitable map for each term of the Agreement, or for any extended term thereof, modified to show the changes, if any, to the State Highways affected by this Agreement.
